Who is Age Friendly Berkshires?








Why Age Friendly Berkshires?



Population over 65 is growing in numbers & percent






2010: Total Population: 131,219 Population over 65: 24,386







- Covers 950 square miles; can take close to 2 hours to drive end to end.
- Far west of the state, bordered by NY, CT, VT; isolated geographically and culturally from the rest of the state.
- Less than 128,000 people in 32 municipalities, the majority of which have fewer than 2,500 people. Population is declining.
- 1/3 of the population lives in the City of Pittsfield, a Gateway City.
- Median household income almost \$20,000 below MA and below the US median. Also a significant population of more affluent and educated retirees, esp. in south county.
- Public transportation is extremely limited.
- Housing is largely limited to 1-family homes, most of which are older homes.

AFB joined the global movement in 2015, on behalf of 32 municipalities




Regional Effort

- Resources spread across the county small towns cannot have everything
- County identity
- Can be challenging, however: large area to cover; 32 separate municipalities, Councils on Aging, etc., as well as self-division into south, north & central county areas.
- Biggest challenge is funding for central coordinator

Early steps

- Assessment, Outreach & Organization:
 - Age Friendly Berkshires Survey
 - Public Listening Sessions
 - Task Force Partners
 - Active Agers Advisory Council


Assessment: Berkshire Age Friendly Survey


- February/March 2015: Age Friendly Survey for Berkshire County adults aged 50 & over
- Distributed paper copies and online through multiple channels; entered into survey monkey
- Almost 2,500 responses! Largely representative by geography, age, income, education.

Aging in Place / Aging in Community

- Respondents want to stay in their community as they age, but even more important is to be able to live independently in their own homes.
- Those with lower incomes and lower education rated staying in their community higher
- Those with higher incomes rated staying independently in their own homes as more important. Stay in Community





55-65% of respondents said they expected to move in retirement; many older respondents had already done so


Reason	Percentage
Move to a smaller home	44%
Want to live in a different climate	38%
Want to be able to walk to parks, stores, town, etc.	38%
Move to a less expensive home or community	32%
Want to be closer to family	24%
Want better access to public transportation	21%
Move to a home that is renovated/modified for older adults or those w/ disability	19%

Where do we expect to live as we age?

- 64% expect to continue to live in a single family house (79% now). Higher for the youngest and wealthiest respondents
- 10% expect to live in a condo or coop (3% now)
- 9% in a retirement community (2% now)
- 3% in assisted living (less than 1% now)
- Do we have enough of these options?
- Other options we didn't ask about?








Social Isolation

- 30% of respondents live alone, ranges from 18% of 50-59 year olds to 61% of those over 80.
- Correlated to income 70% of those w/ income <\$20,000, 10% of those w/ incomes > \$100,000
- 90% have family or friends they can count on in an emergency; 5% do not and 4% are not sure. True across all age groups and income groups.

Communication

- Internet usage was generally high among respondents, highly correlated with both age and income.
- Only 2% of those 50-59 do not use the Internet, compared to 55% of those over 80.
- 97% of higher income respondents use the Internet daily, compared to 35% of those with incomes under \$20,000.
- Overall 84% of respondents use the Internet at least once a week.



Aging in Place Forums

- Held three structured, facilitated public forums – asked for feedback on challenges & potential solutions.
- 150 participants!


